

## **WAVES TRACKER PRIVACY POLICY**

Our privacy policy applies to information we collect when you use or access our website, application, or just interact with us. We may change this privacy policy from time to time. ### **What information do we collect?**

We collect information from you when you register on our site or when you upload your gps and compass log data.

When ordering or registering on our site, as appropriate, you may be asked to enter your: name, e-mail address, or some other personal information.

### **What do we may use your information for?**

Any of the information we collect from you may be used in one of the following ways:

### **How can I manage or delete my account / information about me?**

We may request a copy from a government-issue id to confirm your identity. In addition to that, we aim to have the process finished within 30 days.

## **Do we use cookies?**

Yes (Cookies are small files that a site or its service provider transfers to your computers hard drive through your Web browser (if you allow) that enables the sites or service providers systems to recognize your browser and capture and remember certain information

We may contract with third-party service providers to assist us in better understanding our site visitors. These service providers are not permitted to use the information collected on our behalf except to help us conduct and improve our business.
